When assessing your application, we may need to talk to your support worker or health professional. Before we can speak to them we will need your permission. To give your permission please complete the consent form at the back of this application.

When we have processed your application we will write and tell you our decision. If you do not agree with our decision you can seek a review through an appeals process.

## About General Housing

If you want to live in public housing you must complete this General Application form. If your application is approved you will be offered a property based on the date you applied.

In general, to be considered for public housing, you must:

- Live in Victoria.
- Not own or part own a house, unit or flat (including land).
- Have Australian citizenship or permanent residency status.
- Repay any money that you still owe from a previous public housing tenancy or Bond Loan.

To find out more about your General Housing application, read the information brochure available from your local Housing office.
