Na inn ngeitu he hnatlaknak nan tuah khawh lo ahcun, Consumer Affairs Victoria (Victoria Ramkulh a Ei-ding tu hna Zohkhenhnak bu) sin ah bawmhna na hal khawh.
- zarh khat chung na tangka hmuhmi cu \$1,903 nak in a tlawm deuh lai.
- tangka na khonmi cu \$10,000 nak in a tlawm deuh hrimhrim lai.
